Old Business

Constitution: We will look at the changes one by one.

Motion made by Buckley Second Lynn Approved 4-0

I. Name.

Added B. This organization shall be a not-for-profit 501 (c) (7) incorporated entity. No member organization or individual delegate shall have any vested interest in any funds, property, or assets of the organization.

II. Purpose

Added B. To effect the publication at regular intervals of a magazine containing information of interest to square and round dancers in the state of New Mexico.

X. DISSOLUTION OF NMSRDA CORPORATION, DISTRICTS AND LOCAL CLUBS

Added A. Upon majority vote of the Board of Directors to dissolve the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of NMSRDA to any non-profit corporation that encourages, propagates, and coordinates square dancing, round dancing, and related activities.

X. B. Two Options:

Karen - The districts are children of the state organization, and if the district money is under the state EIN number it is the state money not district money.

Buckley - The state organization can't come and get our district money unless our district allows the state organization to have it?

Karen - Yes, the state organization can ask for the money and take it because it is under the state origination EIN tax ID number.

Buckley - Our district can spend the money how ever we would like to spend the money in our district.

Karen - No, there are specific guidelines on what the money is to be spent on, for example, district dances and callers.

Robert - The guidelines are very broad and not specific at all.

Lorraine - Central District Bylaws state that if Central District folds the left over funds are to be distributed to the clubs which are left dancing in its district organization.

Ken - If the district money is part of the state money; why is the district money not included in the state treasures report?

Karen - I don't know, the only time the state treasurer gets the information is at the end of the year to file the taxes. This creates a huge liability for the state treasurer.

Randy - It's not really a big liability, the tax form asks one question, "Is the organizations income more than \$50,000 of income."

Felicia - If there is already funds in each district account those funds are under the EIN number of the NMSRDA state organization. The district could exhaust the funds in the account with the state EIN number and have their own district EIN Number.

Karen - I think we are setting up NMSRDA up for disillusionment.

Lorraine - We visited all the districts when we got involved with the state organization and when we visited the Southeast district Dorothy Straley voluntarily did the taxes for the NMSRDA and did not require all the paperwork. But did it as a service for the districts, so each district did not have to have their own tax ID number.

Robert - The fear we have is that state board is going to take the money our district has earned. The funds we have in the district is the only thing we have control over.

Karen - If you want your own money that is not controlled by the NMSRDA write a check to state treasurer for everything in your NMSRDA district account.

Robert - Are you saying, we can leave right now, but the money in our district account stays with NMSRDA.

Karen - Yes, that is correct.

Lynn - If you leave the NMSRDA organization the organization gets all of the money.

Robert - Northwest felt forced out of the NMSRDA organization by the board of directors of NMSRDA.

Lorraine - When the Northwest pulled out of the organization these revisions were not in effect and they are not now. They went with their Northeast district bylaws. Constitutions and by laws are a generality on how to run an organization. Districts have more control over their funds than the state organization. Because the state organization and board of directors' job is to put on a state festival and not run the districts. I don't see it as a parent-child relationship.

Motion made by Marvin Second Lynn Option #1 did not pass. 2 for - 3 against

Motion made by Marvin Second Susan Option #2 did pass. 3 for - 2 against

Added B. In the event of the dissolution of a District of NMSRDA, any funds or property will be distributed in accordance with said District By-laws.

Motion made by Karen Second Lynn

Three options Option #3 did pass 4 for - 0 against

Added C. In the event of the dissolution of a Local Club, any funds or property will be distributed in accordance with said Club By-laws. If By-Laws, were created under the State or District EIN then, the state's By-Laws take precedence. If clubs have their own EIN or Tax ID not created under the state's EIN, then the club's dissolution is governed by the owner.

Lorraine - All of XI - XIII - Indemnifications are an addition to the constitution. It is not in the USDA constitution because USDA does not have a constitution, but it is in their By laws. These indemnification recommendations were not accepted as additions to NMSRDA constitution.
