CORPORATION AND FRANCHISE TAX DEPTS.

The undersigned, acting as incorporators of a corporation under the New Mexico NonProfit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is New Mexico Square Dance Association.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To propagate and encourage square and round dancing in the State of New Mexico.
- (b) To effect the publication at regular intervals of a magazine containing information of interest to square and round dancers in the State of New Mexico.
- (c) To cause an annual "New Mexico Square Dance Festival" to be held.

FOURTH: Provisions for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation are:

The conditions and regulations of membership and the rights and other privileges of the classes of membership shall be determined and fixed by the bylaws.

The private property of the members of this corporation shall not be liable for its corporate debts.

This corporation is not organized for a pecuniary profit. It shall not have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director, or individual. The balance, if any, of all money received by the corporation from its operations, after the payment in full of all debts abd obligations of the corporation of whatever kind or nature, shall be used and distributed exclusively for charitable, scientific and educational purposes.
